F.A.Q.:

We have a couple of times through the day where they work on schoolwork mixed with art/game/construction times. We don't guarantee their grades, but we had a lot of success working with families and schools in the spring of 2020 to have Zoom meetings and getting their work done.

Tuition structure is like our summer program. We will not require a 2-week notice, due to the uncertainty of the pandemic. Our plan is that we will offer full day as long as PISD is closed and then we will switch to afterschool when PISD opens to in-person. If PISD is offering in-person, Weekday Program will not offer full-day. Schedule changes for the following week should be submitted by Friday of each week.

The school year registration fee will cover both programs from August 2020-May 2021.

Only students enrolled in the monthly afterschool program may come for break days without additional cost. If PISD is closed leading up to a break (like Thanksgiving) and students are paying weekly, there will be an additional weekly cost for breaks as well.
